



# Terms & Conditions of Membership

## **General Terms and Conditions of Membership**

#### 1. The memberships

The membership of L.S.A. Custodia grants access to all activities organized by the study association for Security Studies and Crisis and Security Management students in The Hague. Some of the events are free, but for some the association may ask for a contribution to realize the activity. In addition, members can participate in a committee or other body within L.S.A. Custodia. Membership is €10,- per year.

#### 2. Membership year

The membership year is the same as the association year and runs from 1 September to 31 August.

#### 3. Renewal and cancellation of membership

The membership of L.S.A. Custodia is renewed automatically, unless a written cancellation (by letter or by email) has been received by the board of L.S.A. Custodia. If you want to cancel your membership, you must send an email to the secretary four weeks before the start of the new academic year. If you unsubscribe after this date, you will remain a member for that year and retain the rights belonging to the membership for another year. Send your email to terminate your membership to secretary@custodiathehague.com, with the subject "Unsubscribe" and state your full name and email address in the email.

#### 4. Membership fee

- A member must pay a membership fee each year for the membership. The fee is set by the General Assembly at €10,-. The changes to this fee can only be made with consent of the General Assembly.
- 2. When registering as a member of L.S.A. Custodia, the member authorizes the association to annually collect the contribution.



- 3. If the member agrees during the sign-up process to the auto renewal of their membership, the following academic year their membership will automatically renew. This results in an automatic collection of the subsequent membership fee. The auto renewal is limited to two years, from the moment of first or renewal of membership.
- 4. If the membership is cancelled during the membership year, no contribution will be refunded.

#### 5. Right of voting

- Members of L.S.A. Custodia have the right to attend the General Assembly and the right to vote at the General Assembly. It is possible to authorize another member to vote for you in the event of absence.
- 2. Authorizing another member of L.S.A. Custodia requires both authorizing and authorized persons to send a written notification of the authorization to the secretary of the board at secretary@custodiathehague.com

#### 6. Statutes and Rules of Procedure

#### 7. Privacy

Personal details are requested when registering for L.S.A. Custodia. These personal details are processed for the purpose of entering into and executing agreements and to inform you about relevant matters in the association. #### 8. Association data

The study association L.S.A. Custodia has its registered office in Leiden at the Turfmarkt 104 (2511DC, The Hague). The association is registered in the trade register of the Dutch Chamber of Commerce.



### 9. Applicable law

On all agreements entered into with study association L.S.A. Custodia and all ensuing obligations are governed by Dutch law.
